The following is a list of things clients can bring with them to their admission to Flint Odyssey House, Inc.:

- 7 Outfits
 - Females: Pants may NOT be: leggings, yoga pants, or stretchy material; unless negotiated for a medical reason. Jeans may NOT have holes in them or be tight fitting. Shorts may NOT be excessively short. Shirts may NOT be: low cut, see through, thin strapped or provocative. No tanks
 - Males: If you need a belt, please bring one. No tanks
 - NONE of the clothing material may be related to: drugs, alcohol, gangs, weapons, etc.
- Undergarments: (socks, underwear/boxers)
 - 14 sets
 - 7 bras
- Sleep clothes:
 - 3 sets, same rules apply for sleep clothes that apply for regular attire.
- 2 pairs of shoes.
- 2 sweaters or sweatshirts.
- 1 winter coat, 1 hat, 1 pair of gloves, 1 scarf.
- All prescribed medications in proper bottles.
- ID, social security card, insurance card, and food card. If able to bring.
- No more than \$20 cash.
- Cigarettes must be: unopened and may NOT be: rolled cigarettes or brown/cigar cigarettes.

The following is a list of things clients can NOT bring to their admission to Flint Odyssey House, Inc.:

- Personal items such as but not limited to:
 - Weapons, sex toys, laptops, tablets, reading material (that is not religious or recovery based)
- Hygiene products even if items are brand new, this includes; Makeup, cologne, perfume, toothbrush. All basic hygiene products will be provided by Flint Odyssey House Inc.
- Straighteners, blow dryers, curling irons, facial hair trimmers, jewelry (this does not include wedding bands/rings).
- Bedding
- Over the counter medication.
- Debit cards or other financial items in someone else's name, this also includes ID's and social security cards.
- Wigs, hair extensions, eye lash extensions, fake nails.
- No purses.
